



HOLYWORD INTEGRITY AGREEMENT

*For Engagement with **Holyword Creative Agency***

Holyword Creative Agency is a sacred offering of **The Holyword Foundation**, a vessel for divine media, prophetic art, and truth-bearing creation. We walk in the spirit of reverence, restoration and righteousness, honouring the living covenant between humanity, the Earth and the Divine. All who engage with **Holyword** are invited to do so in the spirit of truth, love and mutual accountability.

This Integrity Agreement is a ceremonial and spiritual covenant to ensure all relationships with **Holyword** are conducted in alignment with our sacred values and divine mission.

1. Sacred Intention

I, the undersigned, enter this agreement with the intention to participate in the creative work of **Holyword** with respect, transparency and alignment with the greater vision of restoring the sacred voice of humanity.

I affirm that my engagement is rooted in the values of:

- **Truth** — I commit to honesty in all communication and collaboration.
- **Freedom** — I honour the creative sovereignty of all involved.
- **Healing** — I participate in this work as a contribution to the healing of the Earth and humanity.

2. Creative Integrity

I understand that all creations, offerings and works produced or shared by **Holyword** are spiritually consecrated and protected by divine authorship. I agree to:

- Honour the spiritual origin of all content.
- Seek permission before reproducing or sharing materials outside of our agreed purposes.
- Acknowledge co-creative authorship where applicable.
- Avoid misrepresentation, distortion, or misuse of any sacred content, symbols, words or names.

3. Confidentiality and Respect

I will hold sacred any private conversations, creative processes or spiritual insights shared within the **Holyword** collaboration. I will not exploit, replicate, or commodify what is meant to remain in sacred trust.

4. Alignment with Mission

I understand that the **Holyword Creative Agency** is not a conventional media agency but a **sacred vessel** for divine communication and cultural restoration. I agree to:

- Align my projects and intentions with the higher values of justice, peace, restoration and spiritual truth.
- Remain open to spiritual discernment, prayer and reflection as part of the creative process.
- Honour the spiritual leadership and guardianship of **The Holyword Foundation** in discerning what projects are in divine alignment.

5. Right Relationship

I commit to maintaining right relationship through:

- Timely and honest communication.
- Fair exchange of energy and resources (including agreed-upon offerings, donations or financial compensation).
- A willingness to resolve conflict in a spirit of grace, humility, and mutual respect.

6. Termination of Agreement
